TERMS & CONDITION

- **1.** The tender shall have to submitted in sealed cover envelope addressed to the Project Director, Tripura State AIDS Control Society, Health & Family Welfare Department Govt. of Tripura Akhaura Road, Agartala, Tripura (West) on or before **17**th **February**, **2025**
- 2. On the left side of the envelop last date of submission should be mentioned. The tender are likely to be opened on 18^{th} February, 2025 at 04:00 p.m., if possible. Tenderer or their representatives may remain present at the time of opening of tenders. No separate invitation will be given to the bidders.
- 3. The interested bidders shall submit the bids in 2 (two) parts namely Technical bid and the Financial Bid in 2 (two) separate sealed envelopes indicating on the cover as to which one is the Technical bid and which one is Financial bid. The 2 (two) envelopes shall, thereafter, be placed inside a larger seal cover envelope and the same may be submitted. - **6.** On top of the envelope Ref. No. and Name of the tender "Notice Inviting Tender for Lubes" along with full Name & Address with Contact Number, Fax No. & E-mail ID of the bidder should be mentioned.
- **7.** The bid should be submitted in two separate sealed envelopes inside a sealed cover envelope. The contents of the bids should be as:

A. Technical Bid (with self attestation):

PAN Card, Drug License, Trade License in relevant segment, GST Registration with up-to date GST return copy, Professional Tax Clearance Certificate, Experience Certificates in relevant fields of last 03 (three) years, Yearly turn over certificates for last 03 (three) years, Authorization certificate in case of loal bidder/supplier, compliance of specification, Samples for each item need to submitted on or before the last date of submission of the bid etc. An EMD in the form of Demand Draft of Rs. 36,750/(Rupees Thirty Six Thousands Seven Hundred and Fifty) only has to be submitted in favour of Project Director, Tripura State AIDS Control Society. - **8.** Rates should be quoted both in word and figure with GST and no overwriting or incomplete quotation will be accepted.
- **9.** Payments of bill will be made after completion of supply as per supply order followed by satisfaction report of the inspection committee.
- 10. The Tender will be accepted on the lowest rate basis among the technically qualified bidders.
- 11. The undersign reserved the right to cancel or accept the tender without assigning any reasons.
- 12. The supply should be completed within 20 (twenty) days of issuing of work order, otherwise 1% penalty per week will be imposed.
- 13. Tender shall not be accepted for the services for which the concerned company/bidder has been blacklisted/banned/debarred either by Tender inviting authority of Govt. of Tripura or by any other State/Central Govt. and its procurement agencies.

- 14. The concerned bidder/company/agency/if declared as of substandard quality and any criminal case is filed and pending in any court shall not be eligible to participate for those particular products in the tender. Similarly convicted firm/company shall also not be eligible to participate in the tender.
- 15. The Tenders shall have to be type written and in case of any overwriting or cutting, Correction shall have to be made by crossing out neatly. The name and signature of bidder's authorized person shall have to be put on each page of the application. All pages of the tender document shall benumbered and submitted as a package along with forwarding letter on agency's letter pad.
- **16.** Further work order should not be given to those agencies as soon as declared as blacklisted within the validity period.
- 17. A penalty @ 1% on the total value shall be charged for every week or part of week of delay beyond stipulated date of work. However, Relaxation will be entertained only in special circumstances (Natural Calamities, War or any other situation beyond human control).
- 18.5% of the value of ordered quantity will have to deposit as Security Money by demand draft from any schedule Bank by the firm within 7 days from the date of issue of LOI.
