#### **TERMS AND CONDITIONS**

- 2. On the left side of the envelop last date of submission should be mentioned. The tender are likely to be opened on . March, 2025 at 04:00 p.m., if possible. Tenderer or their representatives may remain present at the time of opening of tenders. No separate invitation will be given to the bidders.
- 3. The interested bidders shall submit the bids in 2 (two) parts namely Technical bid and the Financial Bid in 2 (two) separate sealed envelopes indicating on the cover as to which one is the Technical bid and which one is Financial bid. The 2 (two) envelopes shall, thereafter, be placed inside a larger seal cover envelope and the same may be submitted. The Technical bid shall contain all details regarding the items offered, terms & condition and submission of documents etc. i.e. the Technical bid shall contain everything except the rate offered. The Financial bid shall contain only the rate offered by the suppliers/agencies/person. While processing, the Technical bid will be opened first and the eligible suppliers/agencies/person fulfilling all requirements will be short listed. Thereafter Financial Bid of only short listed suppliers/agencies/person will be opened.
- **5.** The bidder must have registered legal entity like an Agency/Firm/Individual. Documents in the form of Certificate of incorporation/registration in support of this are to be provided.
- 6. Bidder should not have been blacklisted by any Central/State Government Department/Agency/Individual regarding quality compromise or any other reason as on closing date of tender. Bidders having any ongoing litigation with any Department/Agency/Individual of Central/State Government are also barred from participation in the tender.
- 7. The vehicles will be hired for 02 (two) year initially. After that on the satisfactory performance it may be extended as per desireness of the authority.
- 8. Bidder should have a valid \*PAN Card, \*GST Registration Certificate with Up-to-date return copy (if applicable), \* Trade License in similar works (if applicable), \*Income Tax for last 03 financial years, \*Professional Tax Clearance Certificate, \*Commercial Registration Certificate of each vehicle, \*Road Permit of each vehicle, \*Pollution Clearance Certificate of each vehicle, \*Insurance Certificate of each vehicle, \*Road Tax Clearance Certificate of each vehicle, \*Fitness Certificate of each vehicle, \*Copy of Work Orders issued from Government Organizations/Establishments/PSUs during last 03 (three) financial years regarding hiring of vehicles.
- 9. The successful bidder shall supply Fuel, Lubricant & Duster etc. for vehicle on regular basis.
- 10. Power of Attorney in the name of authorized signature if applicable.
- 11. The Vehicle shall run anywhere in the State of Tripura as and when required by this office. Driver of the vehicles should maintain Log Book on daily basis.
- 12. All maintenance cost including salary of Drivers, Fooding, Lodging etc. will be borne by the Owner/Approved Vendor. No insurance charge or any other charges is admissible.



- 13. Vehicle should be placed for duty within 10 (Ten) working days from the date of issue of order along with valid commercial driving license of the driver and commercial registration number of the hired vehicle.
- 14. The successful bidder will be liable for the incidence of any loss breakage/accident & legal matters etc. in connection with the vehicle. In case of any defect, breakdown, accident etc., if it occurs at any time, resulting the vehicle unfit for service, this shall be made up by placing another Vehicle within 24 (Twenty Four) hours in order to avoid interruption of this program.

- 15. No claim for advance payment will be entertained. Payment will be made by e-transfer on bill basis along with relevant up-to-date logbook. No enhancement of rates within the validity period of the contract shall be entertained.
- 16. The Vehicle shall have to be placed in places as demanded by the office in all working days of a month and also as and when required by the authority and during such no uses other than by this Society is permissible.
- 17. The Project Director, TSACS reserves the right to discontinue the service of the vehicles notice without assigning any reason.
- 18. Tax should be mentioned clearly/separately in words as well as in figure. All taxes will be deducted as per norms.
- 19. If Drivers are ever found to be intoxicated or indulged in any illegal activities the vehicle will be terminated within a single day notice. Vehicle should be hygienic and punctuality of Driver is mandatory.
- **20.** Under any circumstances, if the driver is not able to perform duties, a replacement by another driver must be managed by the successful bidder immediately.
- **21.** Geographic presence: Availability of office must be located in the state of Consignee, Documentary evidence to be submitted.
- 22. The interested suppliers/agencies/person/owners/bidders shall have to provide only Bank Guarantee till tender validity At-Call/On Demand Pay/Call Deposit from any nationalized Bank for amount of Rs. 5000/- (Rupees Five Thousand) only in favor of Tripura State AIDS Control Society as Earnest Money along with the Technical part only. - 24. The bidder shall quote rate of each item as "Daily Detention Charge" and "Charge per KM run" separately both in figures as well as word clearly. No over writing will be entertained.
- 25. If the party/owner to whom the work order will be issued fails to materialize the work order within the stipulated period of time 10( Ten) days, the earnest money so deposited will be forfeited.
- 26. All vehicle should be of white colour in good condition, having AC facility and year of manufacturing of vehicles should not be less than 2022.
