All bidders are requested to submit the quotation for each item wise separately including GST. #### **Terms & Conditions**

- 1. Sealed Tender in single cover envelope system, i. e, I. Technical bid and II. Financial bid in one envelope (Technical & Financial bid to be provided in two separate sealed envelope. Then both the envelope to be sealed in single cover envelope), Quotation in sealed cover addressed to "The Project Director, Tripura State AIDS Control Society, Health and Family Welfare Department, Government of Tripura, Akhaura Road, Opp. of I.G.M Hospital, Agartala, Tripura (West)- 799001 should reach in the Office of the undersigned on or before 5 P.M. of ILM August, 2025 by speed post/Courier/registered post /by hand undersigned is not responsible for any postal delay. Quotations are likely to be opened on the same day, if possible quotationers or their representatives may remain present at the time of opening of quotations, no separate invitation will be given to the firms/ bidder for that purpose
  - 2. Quotation received after stipulated date & time will be entitled to be rejected. The undersigned shall not be responsible for any postal delay, etc.
  - 3. On top of the envelope Ref. no and name of the quotation Notice Inviting Tender for "Procurement & Supply of Insulin Syringe in NACP facilities" along with full name & address with contact number, Fax no & e-mail id of the bidder should be mentioned.
  - 4. The bid should be submitted in two separate sealed envelopes inside a sealed coverenvelope. The contents of the bids should be as:

## A. Annexure: I: Technical bid (with self attestation):

i) PAN Card, ii) Drug License, iii) Trade License in relevant segment, iv) Non-Conviction Certificate issued by Drug control authority, v) GST Registration with up-to date GST return copy, vi) Professional Tax Clearance Certificate, vii) Experience Certificates in relevant fields of last 03 (three) years, viii) Yearly turn over certificates for last 03 (three) years, ix) Authorization certificate in case of local bidder/supplier, x) ISO/CE/BIS ICMED certificate of the manufacturer, xi) Compliance of specification with product catalogue, xii) Samples for each item need to submitted on or before the last date of submission of the bid xiii) Duly filled annexure- III to V etc., An EMD in the form of Demand Draft of Rs. 1,96,380/- (Rupees One Lakh Ninety Six Thousands Three Hundred and Eighty) only has to be submitted in favour of Project Director, Tripura State AIDS Control Society. This will be released after successful supplier of tendered items. The bidder seeking EMD exemption, must submit the valid supporting document for the relevant category. Under MSE category, only manufacturers for goods and Service Providers for Services are eligible for exemption from EMD. Traders are excluded from the purview of this Policy.



## B. Annexure: II: Financial Bid (name of the item along with specification attached)

- 5. Rates should be quoted both in word and figure with GST and no overwriting or incomplete quotation will be accepted.
- 6. Payments of bill will be made after completion of work as per work order followed by satisfaction report of the inspection committee.
- 7. The Tender will be accepted on the lowest rate basis among the technically qualified bidders.
- 8. Targeted Intervention NGOs attached with Tripura SACS working for the HRGs especially for implementing the needle syringe exchange / harm reduction programme demanded for Needle Syringe (Insuline Syringe-1 ml, 31G, 40 IU) of brand specific i.e manufactured by BD / Dispovan. Hence the bidders / manufacturers to participate in the N.I.T should quote the product manufactured by Becton Dickinson / Hindustan Syringes and Medical Devices.
- 9. The Undersign reserved the right to cancel or accept the tender without assigning any reasons.
- 10. The work should be completed within 15 days of issuing of work order, otherwise penalty will be imposed as per norms.
- 11. Tender shall not be accepted for the services for which the concerned company/bidder has been blacklisted/banned/debarred either by Tender inviting authority of Govt. of Tripura or by any other State/Central Govt. and its procurement agencies.
- 12. The concerned bidder/company/ Agency/ if declared as of substandard quality and any criminal case is filed and pending in any court shall not be eligible to participate for those particular products in the tender. Similarly convicted firm/company shall also not be eligible to participate in the tender.
- 13. The Tenders shall have to be typewritten and in case of any overwriting or cutting, Correction shall have to be made by crossing out neatly. The name and signature of bidder's authorized person shall have to be put on each page of the application. All pages of the tender document shall be numbered and submitted as a package along with forwarding letter on agency's letter pad.
- 14. Further work order should not be given to those agencies as soon as declared as blacklisted within the validity period.
- 15. A penalty @ 1% on the total value shall be charged for every week or part of week of delay beyond stipulated date of work. However, Relaxation will be entertained only in special circumstances (Natural Calamities, War or any other situation beyond human control).
- 16. 5% of the value of ordered quantity will have to deposit as Security Money by demand draft from any schedule Bank by the firm within 7 days from the date of issue of LOI. After getting the security deposit Award of Contract will be issued. The Security Money will be released after completion of full supply within stipulated period and found satisfactory.
- 17. Income Tax / Other Tax & GST shall be deducted from the bill as per guidelines of the Government, if applicable.
- 18. Payment to successful tenderers shall be made on bill basis only after obtaining of satisfactory report of the inspection committee. No advance payment shall be made under any circumstances. Procuring authority may be taken all possible steps to pay the bills within 90 days from the date of completion of supply.

Aus -

- 19. No insurance / Service charge is admissible and successful tenderers will be responsible for any damage and loss in transit on way to destination. Rate approval shall valid for all the health institutions including TI-NGOs across the state of Tripura.
- 20. Any default or breach of contract and non-execution of supply order shall lead to forfeiture of earnest money/security deposit of the successful Tenderers beside to such action as may be considered appropriate by the Project Director, Tripura SACS including black listing / delisting the Tenderers for the future.
- 21. In case of legal dispute the jurisdiction will be the Tripura High Court Agartala.
- 22. The Project Director, Tripura State AIDS Control Society, Agartala reserves the right to accept or reject any Tender without assigning any reason thereof and Tender may be accepted or rejected in part or in whole.
- 23. Submission of any documents beyond the need of N.I.T should be avoided.
- 24. The security money will be released as per Manual for Procurement of Goods, Second Edition, 2024.
- 25. Other Terms and condition will be followed as per Procurement Manual 2018, Govt. of Tripura.
- 26. If it is observed that substandard quality has been supplied then the payment of the same may be held upon. Thereafter the substandard item be replaced with new one. If the replacement is not done by the bidder within a given timeline, the vendor may be blacklisted for three consecutive years in the Health Department of Govt. of Tripura.
